### State of the Trail, NC / TN

The new year gives us pause to reflect on the one that's gone before. (written mid-January) By all accounts, it couldn't have been much better in BMT-Middle. February saw a near-record worktrip turnout of over 30 volunteers for the End Of Construction celebration. Regular monthly work trips began on the newly completed trail and averaged 11.4 maintainers-perouting, a solid start for this most remote segment of the trail.

Volunteer efforts continued to be anchored by 'The Four Horsemen of the Trail Extension'; Clayton Pannell, Ken Jones, Gary Smith, and Robert Owenby. These guys are probably getting tired of being repeatedly thanked for all their work on the BMT. If y'all will alllow me, the BMTA really doesn't have a way to express sufficient gratitude. With deepest appreciation, thank you.

The other 64 (mortal) volunteers brought the total to 68 (not counting Eagle Ranch) people who worked on the middle 100 miles of BMT in 2005. Of these, 16 earned USFS parking passes with 20-or-more hours in the same ranger district. (Six earned passes in 2-or-more districts, one in 3-or-more, and two in all four districts.) Unfortunately, 5 volunteers had enough hours, but they weren't all in the same district. The passes are good for the entire forest where earned. A heartfelt thanks to all who worked, and continue to work, on trail. Also to all you BMTA members who help support this effort with your membership. These funds help us buy tools and run programs that keep the trail open. We together look forward to an even better year in 2006.

### Reroute in Georgia

Our first major relocation since the completion of the trail last year has begun. On Friday, January 13, Tom Keene, George Owen and Walt Cook began flagging a reroute on the south side of Wallalah Mountain. The purpose was to eliminate the dangerous, steep, rocky segment that has caused several falls recently.

We left GA 60 at 10AM and climbed to the second switchback, just below the problem area. The three of us negotiated the steep and slippery hillside, trying to put the trail on areas with surface rock that could be moved, rather than bedrock. We were making good progress when the rain began, followed shortly by lightning and thunder at 12:30. We hurried down off the mountain, getting thoroughly soaked on the way. But the three of us used our down time wisely by sitting in George's living room, solving all the major problems of the world while we dried out.

Saturday morning, we awoke to a snow-covered landscape, but fortunately, the roads weren't icy. We returned to Wallalah and resumed our efforts. By luck, just as we were connecting two segments of flagged route, Tom found an old road that we thought might go to the gap between Wallalah and Licklog. We followed it and it came out on the trail some distance above the gap, but below where the trail gets steep going up Wallalah. So we flagged it back, planning on using it as an alternate route.

Our wanderings brought us to a huge, long monolith that George named Turtlehead Rock. Since it had a large overhang, we sat under it to eat lunch and ponder our next move. That was to re-flag the first line to bring it lower and miss some nasty-looking rock. We think we have a good route, but it will need to be checked, because the great and world-renowned trail expert (Walt) had left the clinometer on George's porch, so all of Saturday's slopes were estimates. We will return on January 27 to tidy up the flagged lines, WITH a clinometer. We will also flag a reroute on the steep upper part of Licklog Mt; and a short one near the GA 60 trailhead, to eliminate a short but difficult series of steps.

Once the Forest Service looks at the route, they will do botanical and archaeological surveys on it. With luck, we may be building new trail next fall.

Q: "I do all my business online using my credit card. With BMTA membership dues coming up, it makes me think of what a pain in the butt it is to write a check, put it in a paper envelope, put a stamp on it (Postal rates have gone up again.) and mail it the old-fashioned way. Why doesn't the BMTA take credit cards and make my life easier?"

Diana Ristom, Publicity Director and Chair of the Website Committee, replies:

As our organization continues to grow, the board is making changes to keep pace. This is one of the potential improvements to be considered this year. Since going to a new webservice provider in December (at a cost savings), the BMTA now has the opportunity to consider accepting credit cards for everything from annual dues to merchandise to special contributions. We must keep in mind that the total costs for this convenience may be as high as 4%. But that could easily be offset by increased activity, i.e. more people joining or renewing because it's more convenient, more merchandise sold, etc.

A nice feature of being able to take credit cards is that anyone would be able to use the service, not just those with internet access. One could not only do transactions on our website, but could also call directly by phone; even hand-written notes delivered in person would work! Unfortunately, even if the board decides to approve this measure, there will be a delay while the website is modified so it probably won't be ready for accepting dues by the cutoff date for this membership year.
