# **Quest for the Benton MacKaye Trail To Be Designated a National Scenic Trail Update**

In May 2022, HB #7884, the *Benton MacKaye Scenic Trial Act*, was introduced in the House by Representatives Steve Cohen and Chuck Fleischmann. Currently the bill has seven co-sponsors.

Now, time is running out for the legislation to be passed during this Congress. A September hearing before the House National Resources Committee is essential to getting the bill included in an omnibus bill for Public Lands, Outdoor Recreation and/or Natural Resources.

A secluded forest pathway traversing 288 miles in three states, three National Forests, six Wilderness Areas and 93 miles in the Great Smoky Mountains National Park, the Benton MacKaye Trail (BMT) definitely exceeds the qualifications for National Scenic Trail designation.

- ♦ The trail's natural, scenic beauty combined with its numerous cultural and historic features make it a shining jewel in the Southern Appalachian Mountains.
- ♦ Ninety-five percent of the BMT is on land managed by either the Forest Service or the National Park Service just 15 miles of the trail remain on public roads/private lands so new land acquisition will be limited and will be on a willing seller basis.
- ◆ The BMT easily meets the standard of long-distance trail viability the Benton MacKaye Trail Association (BMTA) has maintained the trail ever since construction began in 1980 (42 years ago). The association's 771 members include over 200 trail maintenance volunteers.
- ◆ The BMTA has developed a long-standing and positive relationship with both the Forest Service and the National Park Service.
- ♦ The 800-mile Arizona National Scenic Trail is the most similar to the BMT in that the majority of its route is on National Forest and National Park lands. When it was designated in 2009, no Feasibility Study was required − even though more than 100 miles of the trail had not been built and were outside of federal lands.

The BMT clearly meets the requirements of the National Trails System Act for National Scenic Trail status. There is no reason to delay this designation for years in order to have an unnecessary Feasibility Study. To achieve our goal of having the BMT designated a National Scenic Trail, we need Representative Cohen and Representative Fleischmann to advocate for a September hearing for HB #7884 before the House Natural Resources Committee. #### 4-Drawer File Cabinets





# JOE SISSON AND THE VALLEY CROSSING PART 2

Ted Reissing had a successful first meeting with Joe Sisson on the subject of placing the Benton MacKaye Trail (BMT) through the Sisson development northwest of U. S. Highway 76 / Georgia Highway 5 in Gilmer County. Discussion of details relating to the trail location, easements and how the trail would be built were left to the Benton MacKaye Trail Association (BMTA) President Marty Dominy and Trail Construction Supervisor Bill Porter. Bill would go on to serve his first of three terms as president in 1993.

Knowing David Sherman had worked for the National Park Service in the acquisition of property for the protection of the Appalachian Trail, Marty asked him for advice regarding negotiating a potentially donated easement. "Ask for as much as you can get" was the response. "A five-hundred-foot-wide easement would be ideal."

Some days later, Bill and Marty arrived at the Sisson sales office to meet with Joe Sisson. The conversation in the lobby started nicely enough. When the discussion of how the easement would be structured was under way, Marty asked for the five hundred feet that David had suggested. At this point, Mr. Sisson said nothing, got up, and walked into his office. Bill and Marty looked at each as one does when opportunity suddenly vanishes. Yet, Mr. Sisson reappeared a few minutes later and spelled out what was acceptable. There would be a narrow easement through lots that had not already been sold, the trail would follow the development road in areas where lots had already been sold, the easement and trail would be moved within the property if future development warranted it, and his surveyor would prepare a plat and have it recorded. Easements were recorded in the Gilmer County Courthouse on November 13, 1992, and on February 1, 1993.

In the following weeks, there were meetings on the property to determine the route of the trail. At the time, Mr. Sisson's property did not extend to Boardtown Road. To remedy this, an agreement was reached with Mr. Higdon, one of Mr. Sisson's relatives, to locate the trail along a property line and a driveway to reach Lucius Road. After reaching Indian Rock, the BMT ascended the cove as it does now, turned south up a side cove, crossed the ridgeline, and made its way to the property line which it followed west for about a quarter mile. After descending Mr. Higdon's driveway, the new route intersected the old route along Lucius Road at a point 0.6-mile southeast of Boardtown Road. Plans were in place to finish this by National Trails Day in 1993. However, other National Trails Day events and warm weather conspired to keep the volunteer attendance at a modest level for the late spring and summer months. A map and trail description insert for the new route was published in the *August 1993 BMTA Newsletter*. A formal ribbon cutting for the new section was held on September 11, 1993.



Trail improvements did not stop with the ribbon cutting. Lawrence Jump, BMTA vice-president at the time, took a keen interest in this section, and when the opportunity presented itself, led the effort to build a trail shelter below Indian Rock with material donated by Mr. Sisson.

The Indian Rock Shelter was constructed in the summer of 1995. Access to the shelter was via a BMT relocation away from Indian Rock Road that was completed earlier that same year. Lawrence would go on to develop several loop trails connecting to the BMT in the area between Indian Rock and the Higdon easement.





At one meeting, whose date is lost to time, the boundaries of the Sisson property were being reviewed on the sanitized version of the segment map. Mr. Sisson pointed to a property on the map and asked who the owner might be. Marty was a bit surprised as he thought Mr. Sisson would know all of the land ownerships for miles around. Marty checked the roster of landowners and produced the name and address of an individual in Florida. Mr. Sisson scribbled this information on a note pad. By the next time the two talked, Mr. Sisson had purchased the property. In due course, he suggested a new trail route directly to Boardtown Road at the county line as he now owned property extending all the way to that road. The new route extended up the cove past Indian Rock, crossed over the ridge to reach Tipton Gap, and climbed the eastern flank of Patterson Mountain. After crossing the Tennessee Valley Divide twice, the route descended a narrow cove to reach Boardtown Road. By the end of the July 1997 work trip, work on this relocation was substantially complete. As with any number of other relocations, finishing work, blazing and signing would come later as part of individual or small group efforts that were not advertised as regular monthly work trips.



Over the years, minor adjustments have been made in the trail location as more cabins were built. By 2011, it was clear that the bridge in the cove near the railroad would need replacement. Work efforts in July and August of that year not only replaced the bridge in the cove but added two new bridges on either side of the shelter. Again, Mr. Sisson provided materials for this project, including surplus catwalk sections from billboards that now form the deck of the bridge in the cove. His meeting room along Cherry Log Creek was the venue for multiple BMTA meetings.

The old cabin adjacent to the Sisson sales office serves as the BMTA headquarters. For over 30 years, the generosity of Joe Sisson and his family has truly been extraordinary!

# **Upcoming Hikes and Work Trips**

#### **Guidelines for Our Hikes**

Because hiking in the outdoors is good for one's mental and physical health, we encouraged BMTA members and others to continue hiking during the COVID-19 health crisis *and to do so safely*. Thus, we continued our hiking program during 2020 and 2021.

Due to the availability of COVID-19 vaccines, we have further modified our hiking program:

- We have resumed allowing shuttle hikes but caution that (a) no hikers should ride with another or have another ride with them if they are concerned about their safety and (b) unvaccinated hikers should not assume that others will want to ride in vehicles with them.
- Carpooling is permitted but not required.
- Any potential hiker who is feeling ill or has been exposed recently to a person with an active case of COVID-19 must not come on a hike.
- Hikes are limited to a maximum of 10 participants in Tennessee and North Carolina and 12 participants in Georgia. Hike leaders may impose lower limits.
- Masks are optional, but hikers should maintain an appropriate distance from one another.

## Fontana Loop Trail TR157 and Portions of Bee Cove Trail TR421 Closed due to Transmission Line Upgrades

**Robbinsville, NC,** August 22, 2022 - The Fontana Loop Trail TR157 and a portion of the Bee Cove Trail TR421, will be temporarily closed for visitor safety due to transmission line upgrades in the area. These trails are located in the Fontana Village Area of Graham County, NC and are accessed by North Carolina Highway 28N.

Tennessee Valley Authority (TVA) is upgrading high voltage transmission lines to address deficiencies in the electrical power distribution system to Fontana Village. Temporary trail closures are necessary to ensure visitor safety during construction activities. It is anticipated that this project will take approximately 2-3 months and be completed by the end of October. Upon project completion, the trails will re-open to the public. This trail closure will remain in effect until all work has been completed.

As the Benton MacKaye Trail (BMT) runs concurrent with both the Fontana Loop Trail TR157 and Bee Cove Trail TR421 in this area, BMT users are advised to utilize the Fontana Village Shuttle between Fontana Village and Fontana Marina. Walking along North Carolina Highway 28N is not recommend due to narrow road shoulders and winding curves along the highway.

#### **Great Smoky Mountains National**

Park will increase camping fees beginning next year. Parking tags will be also required to be displayed on any motor vehicle parked within the park boundary beginning March 1, 2023.

Approved parking rates are \$5 for a daily parking tag, \$15 for a parking tag for up to seven days and \$40 for an annual parking tag.

Use of all park roads will remain toll free. Parking tags will not be required for motorists who pass through the area or who park vehicles for less than fifteen minutes. Frontcountry family campsite fees will be \$30 per night for primitive sites and \$36 per night for sites with electrical hookups.
